

Recover your domain Procedure Procedure

The system of dispute resolution on the use of domain names. ".Is", developed by the public corporation red.es is based on the practice generally followed in the international arena, and the recommendations by the bodies and agencies international activities related to the management of Internet domain names.

It is necessary to have prior rights of a domain name. ".Is" already assigned to use that system, as established in the Rules of Procedure for Dispute Resolution, adopted on November 7, 2005.

It must demonstrate the reasons why the domain name registration. ".Is" is speculative or abusive, and in particular:

The grounds on which the domain name. ".Is" identical or similar to the point of creating confusion with another term on which the plaintiff alleges Previous own rights and

The reasons it should be noted that the Respondent has no rights or legitimate interests in the name or domain name of the application and

The reasons it should be noted that the domain name has been registered or is being used in bad faith.

In any case, the application must be requested before a provider of dispute resolution authorized by the public entity business red.es, according to Article 13 of the Rules of Procedure for Dispute Resolution.

In the system of dispute resolution of domain names. ".Is", there are several roles, it is useful to know:

Business red.es public entity, in this case the functions are basically enforce the obligations of providers, and execute the resolutions set by the expert. Supplier, nonprofit organization that manages applications, and oversees the processing of the same pursuant to the provisions in the regulations, appointed the Expert with impartiality and independence.

Parties: applicant, person or organization that encourages the application to the supplier against the defendant, owner of the domain name ". Is how the subject of the dispute.

Expert: professional experience in dispute resolution, to resolve the dispute with the utmost rigor and independence, taking into account the contents of the request and reply to it.

Not be started the process of dispute resolution when you open a procedure for cancellation of the domain name. ".Is". In any case, the courts are always open to parties, regardless of the state of demand.

The rate established by the providers of alternative dispute resolution of domain names. ".Is" is 1400.

To address the demand will consider the statements and documents submitted by the parties.

The expert, on average, within 2 months from the filing of the claim, settled by a reasoned decision must be consistent with the claim of demand and can not decide on matters outside it.

Under Article 13 of the instructions regulating the DRP the applicant must indicate on the claim that the claim is sought, ie transfer of the domain name to the plaintiff or the cancellation.

Thus the expert can solve:

Estimating demand

In this case the expert may agree:

Getting the domain name to the complainant. In this case, at the latest within one month from notification of the decision to the parties and red.es, the applicant must submit an application for transmission to transmissionDRP@nic.es. Received this request the transfer of the domain name to the complainant.

Application for transfer pursuant to the decision in the procedure for resolving conflicts:

For end-user domain managed by

Authorization for Agent to act for the Registrar's assigns

Cancel the domain name, which is free for allocation. In the event that the applicant has not indicated in the application you want to transfer the domain name at issue.

No estimate demand. In this case the expert believes that the defendant is right and therefore the domain name must given to the former owner.

If the elapse of 30 days, either party shall notify Red.es a document certifying that it has started a judicial procedure before a competent court, red.es stay the execution of the decision until it receives a communication that has the court proceeding, unless the court determines otherwise.
